Regional Medical Laboratory (RML) has been transitioning to a new platform for Pap, HPV and STI testing over the past several months. This transition has included changing specimen collection devices to Thinprep for Pap and Aptima for swabs and urine. We thank you for your patience during this transition and would like to communicate some additional changes related to this group of tests. We hope to grow the test menu available on Thinprep and Aptima specimens this spring and must make the following changes to accommodate this growth.

Effective March 5, 2018, RML will no longer accept BD ProbeTech swabs submitted for Chlamydia and/or Gonorrhea testing. Also, we will no longer perform Chlamydia or Gonorrhea testing on BD Surepath Pap specimens in-house, and any SurePath specimens received for this testing will be sent to a partner laboratory and may experience extended turnaround time. Chlamydia and/or Gonorrhea testing must be ordered up front on the SurePath Pap and cannot be added on several days after collection. Finally, separate orders for Chlamydia and Gonorrhea on SurePath specimens will be discontinued and simultaneous testing for both organisms will be offered. Impacted orders are as follows:
